Local Aid Annual Funding over \$500 million: \$478 Million in Transportation Trust Fund (State Aid) \$145 Million in Federal Funds

Local Aid Infrastructure Fund (competitive)	\$7.5 Million

TRANSPORTATION ALTERNATIVES PROGRAM (TAP)

The Transportation Alternatives Set-Aside (TA Set-Aside) program provides federal funds for community based "non-traditional" surface transportation projects designed to strengthen the cultural, aesthetic, and environmental aspects of the nation's intermodal system.



SAFE ROUTES TO SCHOOL (SRTS)

The Safe Routes to School Program (SRTS) program provides funds for projects and activities meant to enable and encourage children in grades <u>K-12</u> to walk and bicycle safely to school.





- *Primary pedestrian safety countermeasure involved working with the Federal Highway Administration, New Jersey Department of Transportation, and the North Jersey Transportation Planning Authority to expand and strengthen the Street Smart NJ Campaign.
- ❖ 57 agencies received grants from the State Pedestrian Safety, Enforcement and Education Fund and Federal Section 405 Non-Motorized Fund.
- ❖ Pedestrian Safety, Enforcement and Education Fund Grant Program \$300,000 available for FY 2024.

This program is managed by NJDOT's Bike & Ped unit
