**1. Zoning Atlas Update - Rich Cippoletti, Central Staff**

Central Staff continues to build the NJTPA section of the New Jersey Zoning Atlas. When completed, the New Jersey Zoning Atlas, will become part of the National Zoning Atlas Project database managed by Cornell University. It is composed of zoning details for each municipality compiled into a GIS database.

Zoning laws are complicated and inconsistent throughout our state. This project, by showing the range of laws and allowing comparisons among them, may encourage more standardized zoning, helping real estate developers, policy makers, citizens, and planners improve development.

This effort will help the NJTPA better understand development in the region. This can inform the Long Range Transportation Plan and forecasting models.

The NJTPA is leading the statewide effort. The Delaware Valley Regional Planning Commission and South Jersey Transportation Planning Organization may also participate. NJTPA has also coordinated with the Regional Plan Association on this effort.

The NJTPA has collected and built 92 percent of the GIS database and reviewed 55 percent of the GIS data to ensure it is up-to-date.

Once completed, this dataset will be made available to the subregions for planning purposes.
